Note: Due to various factors, including the volume of participation from districts, contract negotiations for products and services being purchased and delivered within this contract, possible funding changes for districts or ESC Region 11, and other factors, this contract is offered in good faith but does not become binding until September 1, 2023, on either the district or ESC Region 11. This contract is contingent upon the continued availability of appropriations and is subject to cancellation by either party upon thirty (30) days' written notice to the other party. Payment for valid fees or charges rendered by the ESC Region 11 prior to written notice of termination shall be due to ESC Region 11. Early acceptance of this contract is necessary so that ESC Region 11 can plan and prepare to deliver these services. An alternative contract may be offered if this contract cannot be delivered as stated.

++ *Mastery Item Bank Advantage Program:*

*To qualify for the Mastery Item Bank Advantage Program, the following conditions must exist:*

- 1) A district must not be a current Navigate customer, and such district cannot have been a Certica Navigate customer during the six (6) months prior to the purchase of Mastery Item Bank under this agreement.*
- 2) The district must be a current customer of a competitive item bank and will cease using that competitive item bank no later than the end of such district's current subscription term for such competitive item bank, OR district was a customer of a competitor's item bank in the six (6) months prior to the purchase of Mastery Item Bank under this agreement and has ceased using that competitive item bank. A competitive Item bank is defined as a subscription-based, 4-subject bank with more than 10,000 items.*
- 3) Proof of the competitive item bank contract (a copy of the contract, or PO/invoice if a formal contract doesn't exist, showing the period it was most recently subscribed for) and cessation of use or commitment to cease use (such cessation or commitment to cease can be provided by written email confirmation from the district) needs to be provided at time of order.*
